Interested companies shall fulfill the requirements as below:

1. Companies with strong financial capabilities to undertake the project's value.
2. Companies must demonstrate a track record of deploying Automatic Container Damage Detection ("ACDD") and Optical Character Recognition ("OCR") systems on a **minimum of three (3) Ship-to-Shore (STS) Cranes at seaports or terminals** within the past ten (10) years. Preferably, these systems should have interfaced with Terminal Operating Systems (TOS) for at least one (1) year.
3. Companies should have successfully implemented ACDD and OCR systems in **Terminal Gate operations at a minimum of two (2) seaports or terminals** within the last ten years. It is preferred that these systems have interfaced with TOS for at least one year.
4. The Project Manager assigned to the project must possess expertise in ACDD and OCR project management. Hardware Professionals should demonstrate proficiency in infrastructure design and implementation, while Software Professionals must exhibit strong capabilities in OCR software development and machine learning.
5. Proposer shall make payment for the purchase of RFP Documents at **Northport Documentation Centre (DC)** at One Stop Centre. Proposer must present the Official Receipt of payment at Tender Department personnel at Ground Floor, Northport C, to redeem for the RFP Documents.
