PELANTIKAN PEMANGKU KETUA PEGAWAI EKSEKUTIF

Ahli Lembaga Pengarah dan Pengurusan Northport (Malaysia) Bhd (“Northport”) dengan sukacitanya mengumumkan pelantikan **En. Nik Muzani Nik Abdul Aziz** sebagai **Pemangku Ketua Pegawai Eksekutif**, berkuat kuasa **15 Ogos 2025**.



En. Nik Muzani, 50, sebelum ini berkhidmat sebagai Ketua Pegawai Eksekutif Kontena Nasional Berhad (“KNB”) dari tahun 2020 hingga 2025, dengan pengalaman selama lebih dua dekad, termasuk dalam pembangunan infrastruktur, logistik dan transformasi operasi. Nik Muzani telah memegang jawatan kanan di MMC Corporation Berhad dan MMC International Holdings Limited, di mana beliau terlibat dalam projek-projek utama termasuk Projek Bandar Ekonomi Jazan. Beliau berkelulusan Ijazah Sarjana Muda Undang-undang (Kepujian) dari University of the West of England, Bristol.
